- Expand sick leave at ownership discretion and as necessary
- Communicate our best practices to our customers and clients
- Close the office and warehouses for a minimum of 24 hours if a confirmed case of COVID-19 is confirmed (This time will allow us to sanitize and disinfect our work space).

This decision to remain open is one that has been carefully deliberated and will continue to be evaluated, as the landscape for the foreseeable future will remain fluid. As a company we are uniquely positioned to help preserve the integrity of our communities. Our emergency services division will be critical to achieving that goal. Our team at EJH will remain fully engaged and ready to respond to any emergency and to assist our clients with damage from fire, flood, storm, mold, fallen trees, hail, vandalism, emergency board up services and more. We understand that situations such as these happen 24 hours a day, 7 days a week regardless of the current public health crisis. We also understand that many of our colleagues have had to close their doors or suspend operations. We are prepared to respond swiftly to any emergency and will be on call to protect our clients.

Our commitment to quality will remain steadfast. That is particularly relevant when it comes to our emergency board up services. For more than 45 years, we have always completed our board ups with great attention to detail and professionalism. Our board ups leave properties secure and virtually impenetrable. This is compelling in the face of the uncertainty in the days ahead. It is likely that we will see looting and pandemonium. The security of our homes and businesses will be at a premium. The security of our board ups always has been and will remain unparalleled in our industry.
